## **Responsible Procurement**

SQ Stage: all bidders have signed up to LUPC's Sustainability Code of Conduct.

AQ Stage: Responsible Procurement was weighted at 15% of the overall total weighting of 100%. The 15% weighting was split across 5 AQ questions covering the following themes: adherence to the Sustainability Code of Conduct; supply chain mapping, social value, Environmental responsibility and Equipment Disposal.

Equipment Technical Validation: As part of the validation process the following RP related information was collected from suppliers, for each model of equipment submitted for validation by LUPC:

- Country of manufacture or assembly
- Power draw information (standby mode, low power peak power, asset life kilowatts)
- Rates of water usage, water recovery and water costs(for water purification systems)
- Environmental features of applicable products
- The environmental badges stamped on each model (e.g. Energy Star, LEAF, etc.).

Contract Management Stage: In September 2023, all framework suppliers completed a comprehensive Responsible Procurement survey, to collect relevant RP related accreditations, certifications and efforts carried out by suppliers and their supply chain. This information will be made available to members via the Responsible Procurement tool "LUPC RP Hub".
