Responsible Procurement

Responsible Procurement is an important consideration for this framework with a 20% weighting being apportioned during the tender process. This can be further increased to 40% using the desktop calculator should members sustainability requirements need to place further emphasis on this. Additionally, during the quality evaluation suppliers were asked questions covering the following areas:

- MSA Statements and understanding of what they include
- Policies – details on how often they're updated
- Training, how it is administered, how often it is given, how often it is updated and how it is monitored
- Indirect supply chains such as cleaners, warehouse staff, drivers, pickers/packers
- Management of risks in the supply chain?
- Instances of modern slavery which may have already occurred and what action was taken
