Scope of Requirements

This Framework Agreement has been divided into the following Lots:

Lot 1: Total waste management

The management of all waste streams (collection and disposal) produced by a Member Institution, including but not limited to General waste, dry mixed recyclables, food, green (garden and grounds), bulk non-hazardous, wood and metal, hazardous, chemical, WEEE, clinical, pharmaceutical, radioactive, and confidential waste.

Lot 2: General & recycling waste services

The management of General and recycling waste streams (collection and disposal) produced by a Member Institution, including but not limited to General waste, dry mixed recyclables, food, green (garden and grounds), bulk non-hazardous, wood and metal.

Lot 3: Hazardous, Chemical and Radioactive waste

Includes the collection and disposal of all hazardous, chemical and radioactive waste.

Lot 4: Clinical & Pharmaceutical Waste

Includes the collection and disposal of all clinical and pharmaceutical waste.

Lot 5: Confidential Waste

Includes the collection and destruction of all confidential waste.

Call Off Method

Call-off from this framework agreement is by means of further-competition (unless certain exceptions as set out in the Buyers guide apply).
All capable supplier(s) appointed must be invited to submit responses to the institution's mini competition tender document. As all suppliers on each lot may not service all regions. A tool has been provided ("Selection of providers by region tool") which displays the relevant suppliers once you select the required region. Only the suppliers on the Lot that service your region need to be invited.
A mini competition template has been developed to assist you with your procurement. This is not a mandatory document and members can use their own Invitation to tender templates if they prefer.

Responsible Procurement

Built into the tendering process was consideration for environmental, economic, and social issues. The weighting for the responsible procurement evaluation questions was 20% given that this industry has high sustainability impacts.

Areas we considered:

- * Modern Slavery Act- Suppliers demonstrated their approach against modern slavery, human trafficking, forced and bonded labour and labour rights violations in the supply chains.
- * Social Value Act – suppliers' provided examples of tangible benefits they have achieved and delivered on other contracts and describe the social value activities they propose to deliver through the life of the agreement.
- * Reducing carbon emissions - how organisations are minimising the environmental impact of their fleet and the activities involved in the disposal of waste; how they will help members achieve net zero targets; and what do they have in place to support carbon reporting activities of members.
- * Circular economy - How organisations can assist member institutions in achieving circular economy.

All Suppliers on the agreement confirmed:

- * their compliance with the Sustain Code of Conduct.
- * They have access to a waste to energy facility

Added Value

The framework agreement provides a compliant route to market with pre-qualified suppliers allowing members to reduce the time, resources and money usually spent on carrying out a tender of this nature.

The process for carrying out a further competition shall be clearly defined with available templates and guidance for members providing information to carry out a procurement process.

The new agreement has been designed to encourage suppliers to implement sustainability best practice within their own everyday business operations. Sustainability has been built into the procurement process and the specification.

The ability for suppliers to indicate their regional coverage against each lot has enabled the inclusion of some localised suppliers who do not have national coverage.
