### Scope of Requirements

Lot 1 & 2 – Domestic and Non Domestic fired equipment maximum rated input of 500kW & Non-domestic gas fired heating equipment with maximum rated input exceeding 500kW. This may include domestic fired heating equipment such as Gas fired boilers, gas fired water heaters, gas fired domestic gas cooking appliances installed within individual dwellings, within communal plant rooms serving residencies or academic buildings or domestic science laboratories. This may also include non-domestic gas fired boilers, gas fired indirect and direct fired forced convection air heaters, gas fired radiant heaters installed within individual dwellings, communal plant rooms serving residencies or academic building, non-domestic buildings and sports facilities. This list is not exhaustive. This applies to works, as directed, carried out on gas fired equipment in the list above, associated controls and pipework. Although not a mandatory requirement, Suppliers may be requested to provide maintenance and repairs for Oil heating equipment if required.

Lot 3, 4 & 5 - (Variable Geographic Coverage) The provision to undertake a comprehensive Portable Appliance Testing and Microwave Testing service in accordance with manufacturers guidelines, the IET Code of Practice for In-service Inspection & Testing of Electrical Equipment and the Health and Safety Executive. You must also adhere to any relevant British Standards and industry best practice such as the regulations listed within the Specification of Requirements. Awarded suppliers will be responsible for the identification, inspection testing and repair services for a range of electrical equipment.

Lot 6 & 7 - Main Intake Switchgear and supply cables, Distribution Switchgear and sub-main cables, Computer /Data/Telephone Networks, General/Emergency Lighting, Power Installations, HVAC equipment and associated controls (mains supplies) including outgoing circuits from all control panels, Building energy management systems (low voltage control wiring) Fixed Equipment will form part of this contract – this will include: water heaters, fans, space heaters, pumps, hand dryers, - the electrical contractor must test all fixed appliances within each building, All Switch and Fuse Gear – Main Switch Boards – Sub Switch Boards – Main Isolation Positions, Mains Supplies to Security/door access & Fire Alarms and CCTV Installations, External Lighting Installations, Telecommunications Installations (Mains Supplies), Earthing and Bonding Systems, BMS Control wiring to heating and domestic hot water systems – mains wiring, Mechanical Extract Systems (including Ex rated ATEX fans), Fume Extraction and Fume Cupboard Installations, Air Conditioning Installations, Laboratory Gas Installations, Lift Motor Room (all wiring other than lift shaft lighting/controls to lift and car unit), Main supplies only to IT equipment., All external supplies emanating from the building.
