Supplier changes through framework term:

Showcase PSR Ltd acquired Portsdown Office Limited and its subsidiaries in July 2022. From 1st December 2022, the two businesses were integrated and began trading as a single entity: Showcase PSR Portsdown Ltd (Company no: 01779525). This newly named company remains a 100% wholly owned subsidiary of Showcase PSR Ltd

EFG European Furniture Group Ltd changed their name to Elevate Workspaces Ltd in January 2025. In September 2025 the Managing Director confirmed verbally the company had gone into liquidation.

Southerns Broadstock Ltd entered administration on 20th January 2025. The Framework was amended 14th March 2025 to allow Southerns Broadstock Interiors Limited to replace Southerns Broadstock Limited as a supplier on the Lots 2a and 2c in accordance with regulation 72 of the Public Contracts Regulations 2015, specifically under regulation 72(1)(d)(ii).

David Phillips (FF&E) Ltd issued a Notice to Appoint an Administrator 2nd July 2025. The company was wound-up in September 2025.
