Scope of Requirements

The Print Solution PRI3173 NW DPS has been divided into the following Categories and provision of goods and services:

Category 1- Printed Stationery (e.g. envelopes, letterhead, labels)

Category 2- Security Printing (e.g. exam booklets, badges)

Category 3- Printed Prospectuses

Category 4- Printed Marketing Materials (e.g. leaflets, banners, posters)

Category 5- Digital Print Services

Category 6- Print Managed Service

The Scope of the DPS includes, but is not limited to, services that aid with the management of fully comprehensive end to end printing services from initial design to delivery, covering both services and finished physical or digital goods.

The scope will include both small volume and bulk printing- including lithographic, digital, large format, wide format and accessible printing; binding, copying, laminating, embossing and finishing. Products will include but not be limited to pre-printed stationery incl. envelopes, labels, postcards, booklets, calendars etc.; printing related to 'security' such as exam documents, name badges, plastic ID cards etc; printed and digital materials such as prospectuses, marketing fliers/leaflets, banners, signage, posters, brochures wallets and folders. The scope covers the provision of all elements of design work, web2print functionality and the fulfilment, packaging, storage and distribution of the in scope goods.

The scope also includes direct mail including database management, design and personalisation, printing, finishing, collation, and mailing of items to end users, on a non-mandatory basis.

Categories 1-4 cover the provision of the following services for the relevant category of product: Design and pre-production work, a range of printing services, finishing services and fulfilment.

Category 5 is for the provision of Digital Print Services only. Digital print jobs may be small or large quantity and cover design and pre-production, printing (digital only), finishing and fulfilment.

The scope of Category 5 also includes Direct Mail on a non-mandatory basis. Member institutions will define print management service requirements at call-off and not all in-scope services will be required in each instance. All printing and personalisation will be in line with data and/or artwork as received and/or agreed.

Category 6 Print Managed Services is to allow member institutions to access a neutral vendor to obtain the best value service for members. The neutral vendor will appoint and manage suppliers capable of providing the services covered in Categories 1-5.

Geographical Coverage:

For Categories 1-5, suppliers only cover certain geographical locations as provided at their appointment onto the DPS agreement.

For Category 6, the vendor (main supplier) is required to provide coverage across the whole of the UK.

The qualitative evaluation criteria may be further sub divided into more specific criteria relevant to your individual requirements, but must be set out in your Invitation to Mini-competition.

The NETpositive Supplier Engagement Tool will be used as part of contract management. The UKUPC Supply Chain Code of Conduct was issued to suppliers as part of this tender.

At Selection Suppliers were assessed for:
