This eTendering platform is a digital system that manages the tendering process online. It allows buyers to publish procurement opportunities and suppliers to submit bids electronically, ensuring transparency, efficiency, and compliance. The modules offered are: Tendering, Bid Evaluation, Contract Management , DPS and eAuctions.

The purpose of this single lot, ranked, multi supplier Framework Agreement is to provide the choice of an Tendering platform , for Consortia members to carry out regulated PCR 2015 and PA2023 (Procurement Act 2023) procurement processes.
