- Link bridges
- Specialist window cleaning services (eg, abseiling)

High-level cleaning, including but not limited to:

- rooftops
- Cladding cleaning
- Removal of bird guano from outside window ledges and surfaces
- Pigeon proofing
- Lot 2 – Grounds Cleaning

Grounds cleaning including but not limited to:

- Power hosing / jet washing external areas
- Graffiti cleaning
- Bus/smoking/bike shelters
