## Scope of Requirements

The agreement covers the procurement of commercial removals and relocations and is split into 5 Lots:

Lot 1 - General (Low Value Items / Lower Risk) Commercial Removals and Relocations eg office furniture, filing etc. May include packing and unpacking services, and off-site storage

Lot 2 - Specialist (High Value Items / Higher Risk) Commercial Removals and Relocations eg IT Equipment, Laboratory Equipment, Engineering/Workshop Equipment, Art Museum and High Value Artefacts, Library Collections (with suppliers confirming the specialisms they can satisfy) May include packing and unpacking services, and off-site storage.

Lot 3 - Crate Hire/Purchase and Packaging Products

Lot 4 - Domestic Style Removals and Relocations eg employee relocation within UK, porter assistance for students moving into university accommodation

Lot 5 - International Moves (Not including international employee relocation, that is available through agreement PFB3135 NW Global Workforce Mobility Services)

### Call Off Method

Call off from the Framework Agreement is by means of either direct award or further competition.

Direct award options - business case method, or ranked method  
Further competition options - desktop calculator method, or competitive quotation method, or mini-tender method

### Responsible Procurement

Responsible Procurement/Social Value was given an 18% weighting in the evaluation with Suppliers asked questions related to the themes:

- Improving Health and Wellbeing - Demonstrate action to support the health and wellbeing, including physical and mental health, in the contract workforce
