## Scope of Requirements

The purpose of this framework agreement is to provide members with access to Legal Services to support their organisations across a broad range of legal practice areas. While predominantly for the legal jurisdiction of England and Wales, it allows for law firms under the framework to provide legal services for the jurisdictions of Scotland, Northern Ireland, Law of Guernsey, Law of Jersey, Law of Isle of Man, European Union Law, and International.

The framework has one lot, made up of three sub-lots. All lots provide for the same services with the only differentiator being the hourly rate of the seniority rates.

1B - Group B Full-Service Law Firms – Law firms appointed have a mean average of seniority level rates of between £200 and < £250 per hour.

1C - Group C Full-Service Law Firms – Law firms appointed have a mean average of seniority level rates of £250 per hour
