The scope is determined by the lots definitions, and within these, by the Equipment Types that fit under each lot.

The scope covers a wide range of laboratory equipment that would be expected and required in a fully functioning scientific laboratory, either for teaching, research or other scientific purposes.

The scope has been achieved and refined through successive terms managing this framework. Relevant Equipment Types have been added where pertinent, and where there are no other better suited UKUPC frameworks available.

EQUIPMENT:

The current technical scope is provided in Section 2 of the Buyers Guide and also as a standalone Excel file. Customers can request items that are not in the pricing schedules, as long as they fit robustly and truthfully within the relevant Lot and Equipment Type definitions. Responsible Procurement

Responsible Procurement (RP) and a Whole Life Cost approach to equipment choice played a key part in the design of this agreement.

- RP was heavily weighted at 15% of the overall total weightings. These consisted of a number of targeted RP questions in the Award Questionnaire, which are available to review.
- Q3 of the Award Questionnaire was specifically to assess and score bidders' approach to Whole Life Costs, when recommending products to customers.
- The RP questions mirror the RP Section of the General Specifications document, see Section 8.
- The price files offer Kilowatt Per Hour at Set Point data.
- The price files also offer suppliers' recommended lowest Whole Life Cost models equipment under Model 7, and the some price files offer reasons why these models are considered best value in terms of Total Cost of Ownership.
- All framework suppliers completed a comprehensive Responsible Procurement survey, to collect relevant RP related accreditations, certifications and efforts carried out by suppliers and their supply chain. This information will be made available to members via the Responsible Procurement tool "LUPC RP Hub".

Added Value

- Fully compliant route to market for participating Institutions (compliant with PCR 2015 and EU regulations).
- Access to market leading suppliers and innovative concepts and instrumentation.
- Time saving, members can use the framework rather than completing a full tender process.
- Call offs purchases will be covered by UKUPC's pre agreed Terms and Conditions of trade, oriented towards members' needs.
- Fixed commercial terms on all lots, via maximum tender pricing files (or 'ceiling' pricing), which is the maximum price that should be paid when direct awarding or via desktop exercise.
- Additional cost savings possible via mini competitions based on the specific requirements, aggregation and higher volumes. This provides potential to report cashable savings.
- Suppliers have been encouraged to promote product lines to manage and reduce Whole Life Costs.
- Framework pricing will be lower than non-framework pricing and will include a process for price checking which is linked to supplier KPIs.
- Customers will be supported by LUPC if account management escalation is required.
